Hey All,

(From May) Hope all is well with you guys and girls. Well it has been a bit since we have met, and I'm looking forward to seeing you all again. My schedule has given me a bit more time in the shop and things are looking good. With the recommendations of the Governor we will delay our meeting for another month.

So in the shop this month I've been moving forward on my exhaust system for the little O-200 that is stationed on the front of my Zenith. If you recall it is a replacement system and upgrade for the stock units from Continental. I was just about to finish the welding on the exhaust flanges when I ran out of Argon for the TIG welder. What a bummer, so close. Just in case you are tempted to build one of these systems with .040 304 Stainless tubing I have almost \$700 in tubing alone and close to \$100 in welding rods, and I'm on my second 80 cubic foot bottle and third 40 cubic foot bottle (for back gassing) of Argon. So, it's adding up quickly!

At any rate it looks pretty good and I hope the performance upgrade is worth the headache. Once I have more argon, I can finish up the welds on the flanges. Lastly it will be work on the carb and cabin heat boxes for each side.

The next big adventure is going to be getting the wings reattached. That process should be happening before the next meeting. I'll be sure to add some pictures when that happens!
