really know why the RV's are incredibly popular.



NEXT LEVEL OF FLIGHT SIMULATION AT SMA

The downturn in the economy hasn't stopped the expansion, growth and upgrades that have been occurring at the Sanford, Maine airport FBO, Southern Maine Aviation.

The grounds of Fantasy of Flight were turned into a aircraft camp site during Sun 'n Fun 2011. As always, Thursday, March 31 is seaplane competition day at Lake Agnes, with waterbombing, spot landing and a seaplane fly-by at KLAL. All the water flyers celebrate that night with the annual Seabirds Banquet, at Fantasy of Flight.
